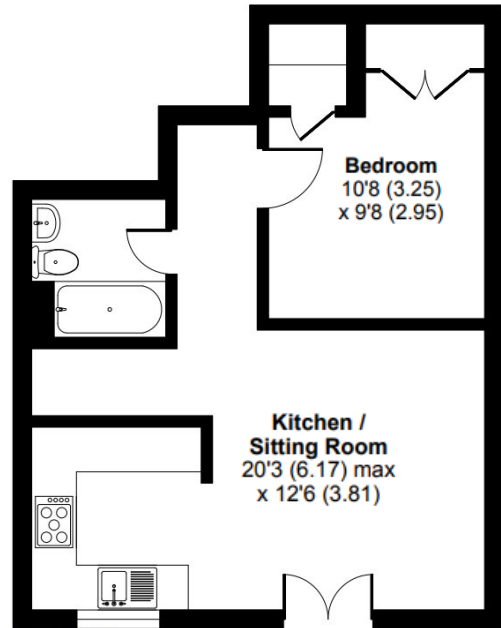
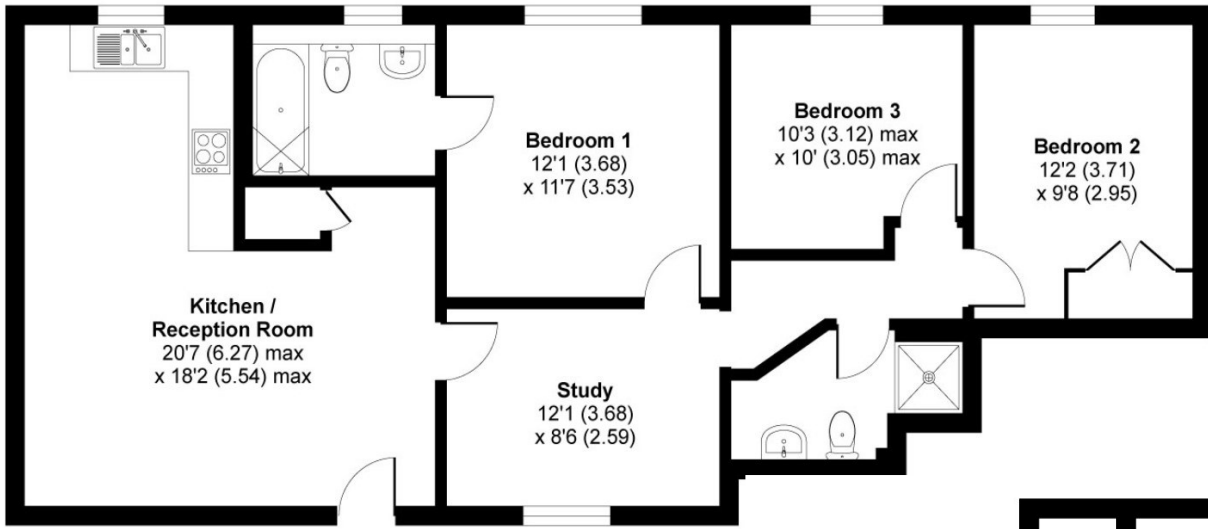
East Garston

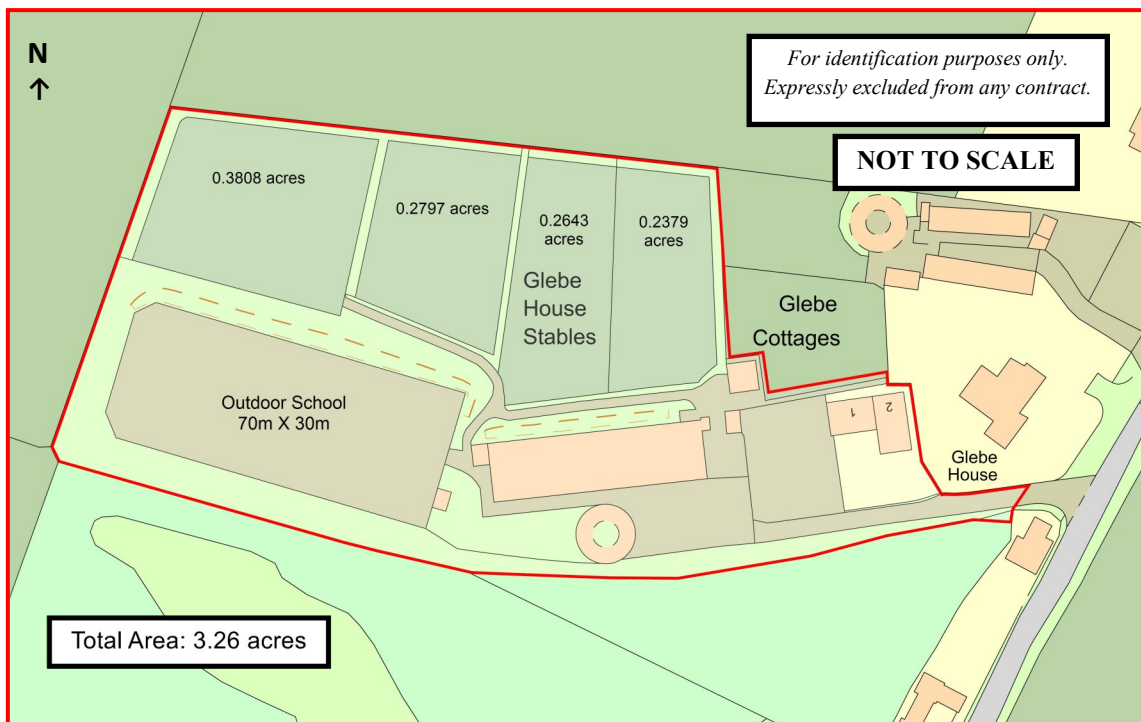
2 Parsons Close (right)

461 sq ft. Open plan kitchen/living area, good sized bedroom and a bathroom. Outside is an enclosed patio area.

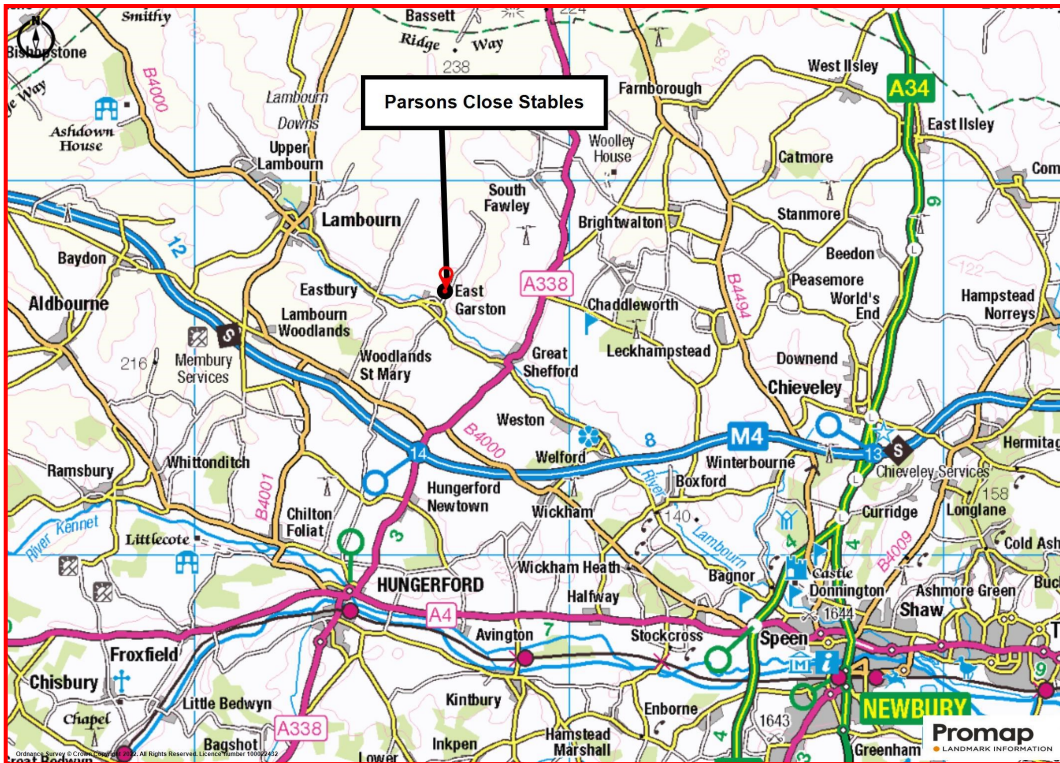
There is shared parking to the side of the cottages.

From Junction 14 of the M4 take the A338 toward Wantage. Take the first left at The Pheasant Inn. After 1 mile turn right onto Goodings Lane, sign-posted for Goodings/East Garston. Follow Goodings Lane until you reach The Queen's Arms, East Garston. Turn right and then immediately left onto Front Street. Follow this road for a quarter of a mile before turning right onto School Lane. Parsons Close Stables is 350 meters on the left.
